If sufficient investment income is not available on a monthly basis, the Funds will distribute long long-term capital gains and/or return capital to their shareholders in order to maintain a level distribution.

(3) The Fund has distributed more than its income and net-realized capital gains in the current fiscal year; therefore, a portion of the distribution is return of capital. The Fund sends shareholders a 1099-DIV that indicates how distributions should be reported for federal income tax purposes.
